### T.S. ELIOT SOCIETY SESSION AT ALA CONFERENCE

The T.S. Eliot Society is again participating in the annual conference of the American Literature Association, which will take place at the Stouffer Harborplace Hotel in Baltimore on May 28-30, 1993. The ALA is a coalition of approximately thirty-five American author societies and has been sponsoring a conference annually since 1990. The Eliot session will be chaired by Vinni Marie D'Ambrosio, and includes the following presentations: John Zubizarreta (Columbia College, SC), "T.S. Eliot and Gabriela Mistral: The Language of Desire and Death in *The Waste Land* and *Desolación*"; Benjamin G. Lockerd, Jr. (Grand Valley State University), "Fractured Atoms: Eliot's Critique of Atomism in *Gerontion*"; and Grover Smith (Duke University), "Trivia and Transformation: Three Notes on Eliot's Poetic Art."

Members of the T.S. Eliot Society are automatically members of ALA and are entitled to attend its conferences. The registration fee this year is \$35 (\$10 for retired persons, independent scholars, and graduate students) and should be sent to ALA, c/o Alfred Bendixen, Executive Director, California State University, 5151 State University Drive, Los Angeles, CA 90032. For reservations (\$70 single, \$80 double) call the Stouffer Harborplace Hotel in Baltimore. Conference sessions will begin on Friday May 29 at 9 a.m. and the closing festivities will take place in early evening on Sunday May 30.

### ANNUAL SOCIETY MEETING: FINAL CALL FOR PAPERS

The fourteenth annual meeting of the T.S. Eliot Society begins on Friday September 24 and continues through Sunday September 26. Once again most of the activities will take place at the Drury Inn at Union Station in St. Louis (314-231-3900). If you wish to present a paper, please send a proposal by June 15 to Vinni Marie D'Ambrosio, 11 Fifth Avenue, New York, NY 10003. Papers should not have been published previously and should take no more than 20 minutes to read. The Board also welcomes recommendations for

session topics and for other activities at the annual meeting. Two members of the Board, Virginia Phelan and Grover Smith, have extended an open invitation to any member seeking advice on prospective papers or presentations.

The September 1992 meeting featured Denis Donoghue's Memorial Lecture, "The American T.S. Eliot"; a ragtime performance including "The Shakespearean Rag"—the 1912 hit immortalized in *The Waste Land*—and Trebor Jay Tichenor's "The T.S. Eliot Society Rag," a work commissioned by the Society; an excursion to the Cohokia Mounds, the site of the largest population center in North America a thousand years ago; David Huisman's slide presentation of places associated with *Four Quartets*; and papers by various members of the society—Grover Smith, "The Provenance of the Rattling Bones in *The Waste Land* (lines 185-6); Mark Jeffreys, "Parallel Syntax: Samuel Johnson's Prose and T.S. Eliot's"; Benjamin G. Lockerd, Jr., "Protozoic Slime: Eliot's Attack on Darwinism"; Lee Oser, "Ethics and the Construction of Value in *The Waste Land*"; and Nancy Hargrove, "*The Waste Land* as a Surrealist Poem." The Conference also included an Open Forum on Friday evening, a reception at the home of Anthony and Melanie Fathman on Saturday evening, and Rev. Earl K. Holt's annual address at the First Unitarian Church on Sunday morning.

The program for the 1993 annual meeting will appear in the summer issue of *News and Notes*.

**CHRISTOPHER RICKS  
1993 MEMORIAL LECTURER**

Christopher Ricks, author of many distinguished editions and critical studies of English poetry, will deliver the T.S. Eliot Memorial Lecture at the Society's annual meeting, which will take place in St. Louis September 24-26.

Mr. Ricks is currently Professor of English at Boston University. His many publications include *Milton's Grand Style* (1963); *The Poems of Tennyson* (1969); *English Poetry and Prose: 1540-1674* (1970); *English Drama to 1710* (1971); *Tennyson* (1972); *Keats and Embarrassment* (1974); *The State of Language* (1980); *The Force of Poetry* (1984); *The Tennyson Archive* (1987); *The Poems of Tennyson* (1987); and *T. S. Eliot and Prejudice* (1988).

**BOARD OF DIRECTORS:  
TWO POSITIONS VACANT**

At the annual Board meeting in September Virginia Phelan was elected to the position of Historian of the Society. As a result of her election as Historian and the death of E. Philip Bollier, there are currently two vacancies on the Board of Directors. The terms for both positions will begin on June 1, 1993 and last for three years. Four members of the Society have received the five required endorsements for nomination: Shyamal Bagchee, William C. Charron, Joan Fillmore Hooker, and Mark Jeffreys. Shyamal Bagchee, of the University of Alberta, was the Society's Memorial Lecturer in 1990. He has edited two collections, *T.S. Eliot Annual* (No. 1) and *T.S. Eliot: A Voice Descanting*. He participated in the Eliot Centenary conferences at Little Rock and Orono, and in the Society's 1991 ALA session in Washington.

William Charron, of St. Louis University, presented a paper on Eliot and F. H. Bradley at the Society's 1991 annual meeting in St. Louis. He is editor of *The Modern Schoolman* and currently planning a special issue on Eliot.

Joan Hooker, of New York University, is the author of *T.S. Eliot's Poems in French Translation: Pierre Lyris and Others*. She read papers on related topics at the Orono conference and at the Society's 1992 ALA session in San Diego.

Mark Jeffreys, of the University of Alabama at Birmingham, took part in the Society's 1991 ALA session and in the 1992 annual meeting in St. Louis, presenting papers on Eliot's debt to the prose of John Donne and Samuel Johnson.

The other elected members of the Board are Melanie Fathman (to 12/94), Grover Smith (to 12/94), Ann Brady (to 6/95), and Lois Cuddy (to 6/95). *Ex Officio* members are Vinni Marie D'Ambrosio (President and Chair), Sanford Schwartz (Vice-President), Mildred M. Boaz (Secretary), Linda Wyman (Treasurer), Virginia Phelan (Historian), and Early K. Holt III (permanent member).

**E. PHILIP BOLLIER:

Last year the Society mourned the death of E. Philip Bollier, professor of English at Tulane University and an active mem-
