2013 MEMORIAL LECTURER JAHAN RAMAZANI

Jahan Ramazani is Edgar F. Shannon Professor of English at the University of Virginia. His 2013 Eliot Society lecture draws from his new book, Poetry and Its Others: News, Prayer, Song, and the Dialogue of Genres, forthcoming from the University of Chicago Press. Ramazani is the author of A Transnational Poetics (2009), winner of the 2011 Harry Levin Prize of the American Comparative Literature Association, awarded for the best book in comparative literary history published in the years 2008 to 2010. Previous books include The Hybrid Muse: Postcolonial Poetry in English (2001); Poetry of Mourning: The Modern Elegy from Hardy to Heaney (1994), a finalist for the National Book Critics Circle Award; and Yeats and the Poetry of Death: Elegy, Self-Elegy, and the Sublime (1990). He edited the most recent edition of the Norton Anthology of Modern and Contemporary Poetry (2003) and, with Jon Stallworthy, The Twentieth Century and After in the Norton Anthology of English Literature (2006, 2012). He is also an associate editor of the new Princeton Encyclopedia of Poetry and Poetics (2012). He has received a Guggenheim Fellowship, an NEH Fellowship, a Rhodes Scholarship, the William Riley Parker Prize of the MLA, and the Thomas Jefferson Award, the University of Virginia's highest honor.
