2014 MEMORIAL LECTURER SARAH COLE

Sarah Cole is Professor of English and Comparative Literature at Columbia University and recipient of a 2014 Guggenheim Fellowship. Her most recent book, At the Violet Hour: Modernism and Violence in England and Ireland (Oxford, 2012), investigates the strange proximity of modernist aesthetics and violence in the late nineteenth and early twentieth centuries. In particular, Cole reads The Waste Land in the context of the First World War to examine the polarizing relationship between "enchanted" and "disenchanted" violence. Her Modernism, Male Friendship, and the First World War (Cambridge, 2003) explores the literary and cultural history of masculine intimacy in the twentieth century. Her article on The Waste Land and violence appeared in PMLA, and she has also published in Modernism/modernity, Modern Fiction Studies, and ELH. Cole teaches courses on British literature of the modernist period, and her work on modernism is oriented toward history, with a particular focus on the First World War.
